The all-out backwoods and tree front of the nation are assessed to represent 23.68 percent of the nation's territory (Chapter 3, n.d.).

India contains an extraordinary abundance of biodiversity in its woodlands, wetlands, and marine regions. The nation has seven percent of the vertebrates, 12.6 percent winged creatures, 62 percent reptiles, 4.4 percent creatures of land and water, 11.7 percent fishes, and six percent plants of the world. The Western Ghats and Eastern Himalayas are biodiversity hotspots. The faunal species inside the nation is assessed to be around 81,000, speaking to about 6.4 percent of the world's fauna. The quantity of plant species inside the nation is assessed to be more than 45,000 speaking to around seven percent of the world's verdure, including 1228 fowls, 428 reptiles, 372 vertebrates, 204 creatures of land and water, and 2546 fish species. India is home to 14 biosphere holds, of which three are on the planet organization of biosphere save for example Sundarbans, Gulf of Manner and Nigiri (Chapter 3, n.d.).

Natural, Social and Cultural Impacts and Human-Wildlife Conflicts
