I. INTRODUCTION

Astral projection is the method used by ancestors particularly in the Hindu religion. Astral Projection means an out-of-body experience that is soul or consciousness can separate itself from the body and move anywhere in the universe. Also, they have the capacity to enter in any dead body and make that body to live again with their soul.

Tamil Literature is the richest literature that has a long tradition for more than two thousand years in the Tamil language. It is evident that in Tamil literature, one who rules the kingdom must master the Sixty-Four arts of life. Astral Projection is numbered fifty-second among the important arts. Next, is about siddhi which is a Sanskrit word meaning success, accomplishment, attainment, perfection. In Hinduism, there are eight classical siddhis such as anima which decrease the size of the body to atom, Mahima which enlarge one's body to unlimited large size, Laghima becoming weightless, prapti which exercise power to be anywhere of one's own wish, prakamya in which one can understand anyone's wish, Isitva in which Astral projection i.e. exhibiting supreme power over nature, vasitva in which one can controls nature and natural forces, Garima in which one can gain the power to become very heavyweight are attained through the sincere meditation, attaining extreme power through yoga and the spiritual maturity over the extraordinary power of the soul. These unbelievable elements can only be achieved by great saints and yogis as follows

Thirumoolar:

One of such yogis is the close disciple of Lord Shiva, known as Thirumoolar Tamil Shaivite and writer. He was one among the sixty-three nayanmars and one among eighteen popular siddhars in Tamil literature. His famous book is thirumanthiram. Such a great siddhar is the one who had practiced the sixth siddhi, astral projection among eight, during the ancient period. Patanjali was a great sage in India lived in 2^{nd} century BCE who also quote about the astral projection in his yoga formulas verse number 3.38 in which he told that one who leaves the familial bond, attain the eternal bliss of god and learn to control the five elements of nature such as earth, water, air, sky and firethrough the meditation and yogasanas can separate the soul from the body and control it to their wish to live the eternal life. Mind integrity is a significant aspect that helps the siddhars to attain this kind of supreme power.

Agathiyar:

Another great legend to speak about is Agathiyar. He is known as the father of Tamil literature. There are 18 great siddhars in Tamil literature who acquire immense knowledge and experience by practicing spirituality and yogasanas. They possess great knowledge in many fields such as Siddha medicine, meditation yogic exercises, Astrology, Alchemy and occult practices. Agathiyar is regarded as the first great sage in Tamil literature. He is the direct disciple of Lord Shiva who possesses immense knowledge in Language, medicine, Alchemy, spirituality and astrology. The details about Agathiyar maharishi is given in all the four Vedas such as Rig, Yajur, Sama and Atharvana parallelly eight anthologies of Tamil Sangam literature such as Akananuru, Purananuru, Ettuthogai and so on also speak about Agathiyar. This becomes more controversy because eight anthologies of Sangam literature and four Vedas belong to different centuries withthe difference of manyyears. It is believed that Agathiyar with his spiritual power, lived and living till day. It is also believed that he does not have a physical body but a living soul.

Bogar:

Bogar or Boganathar disciple of Agathiyar lived between 550and 300 BC. He is a great expert in the field of Pharmacognosy which means the study of herbs, plants and natural resources which have many medicinal uses. He is the one who taught immortality through kayakalpa yogasanas. Statue ofLord Muruga in Palani Temple is made by Bogar with the Nine auspicious Poisonous herbs into medicine which cures any disease. He also practiced Astral Projection. It is believed that he attained immortality by merging his soul with the universe and god through mind integration.

Butday to day life, in the fast living world, no one has free time and passionbecause of their busy schedule with their duties. Everyone become multitasker and so there is no possible way to exercise mind integrity in any work. Thus, it becomes very difficult to believe the activities of the siddhars. Every one trusts science for any facts and rely on it. Time changes everything. Once in an ancient period, immortality is practiced but it is impossible now. Currently, in science, Research in neuroscience is in the process to find out the formula for immortality. Meanwhile, there is a story known as Samudhra Manthan in tamil Literature which narrates the experience of Rishis in finding out the Amrita, The Elixir from god which helps to be immortal.

Samudhra Manthan: (Churning the ocean of milk)

Samudhra Mandhan is also known as Amrit Manthan. The word Samudhra means Ocean, Manthan means Churning. The pieces of evidence about SamudhraMandhan is narrated in an epic such as Bhagavat Geetha, Vishnu Purana and Mahabharata.

Lord Indra is the king of heaven, the more powerful god who can control thunder, storm, lightning, rain, war, etc. he is highly respected for his immense knowledge in Vedas i.e. contains the protocols to be good in character as well as life. Once lord Indira takes a ride in his elephant Airavata and comes across the great sage Dhurvasa. Sage dhurvasa presented him a garland which is very auspicious and brings fortune to life. Lord Indira politely received the garland and kept in the horns of Airavata. Unexpectedly Airavata threw the garland away. By seeing this, sage dhurvasa got angry about the pride of lord Indira, cursed him and other gods to lose their powers, energy, strength and fortunes. Vasuki is a snake so it emits poison while churning which is very harmful. So, Lord Vishnu advised Lord Indira to trick the demons by holding the tail part of the snake god to churn. Thus, making demons to face the poison which leads to death. After the great struggle, the divine Physician Dhanvantri appeared from the ocean of milk with the pot of Nectar which is the Nectar of Immortality also it replaces the power of all the gods.

In Hinduism, it is believed that once the great saints, Gurus (Teachers) are the ancestors who achieved the stage of immortality through their divine power of meditation, mental integrity, and spiritual energy. But in today's life mind integration becomes impossible. Everything is passed on to the next generation only through the texts. There is no hint or evidence in any books or scriptures about the

formula, way or method to attain immortality. Everything is buried as secret. Mayavan is a science fiction crime thriller, Tamil movie released on December 01, 2017, directed by C.V Kumar. This movie is about the investigation of the series of murders in the same pattern. In every murder, the suspects are different with no relativity but all their attitudes are the same. Also, they leave a lot of evidence about them in the crime spot. It becomes very easy for the cops to track the murderers but it is understood from the statement of prime suspect's family members that before fifteen days from the date of the murder, their activities, behavior, attitude, personality, approach, look everything is changed almost like a different person. i.e. they changed their originality. If the murderers get caught by the police, they voluntarily commit suicide and die. Next within the few days murder happen and the same process continues. But this time police, trap the person and enforce a polygraph test on him to find out the truth. 


Figure 1: Milestones of Avatar 2045 Project. Ref: 2045.com/images/plan/28695.html
