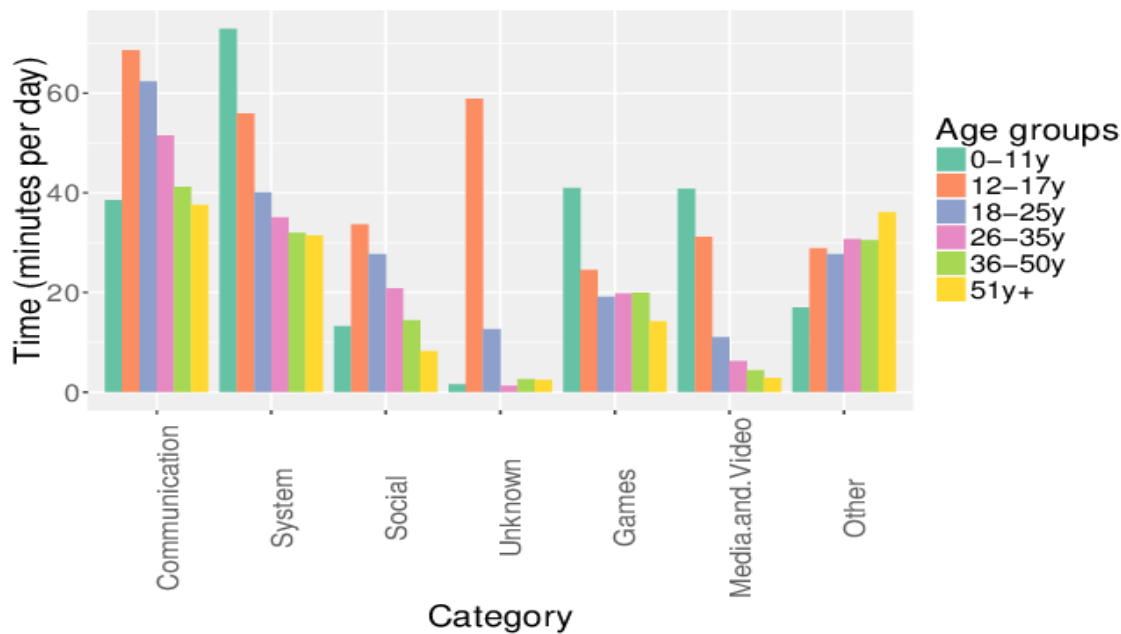


Figure: 1 Times Spent on Daily Phone Ages by Various Age Group

H2: There is no relation of using social media on female children's health.

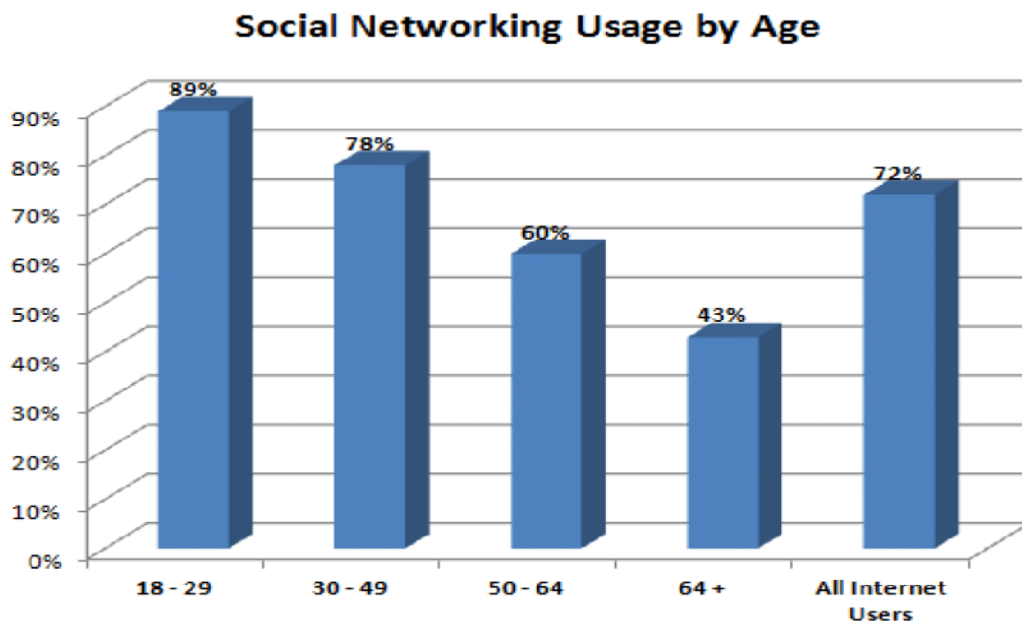

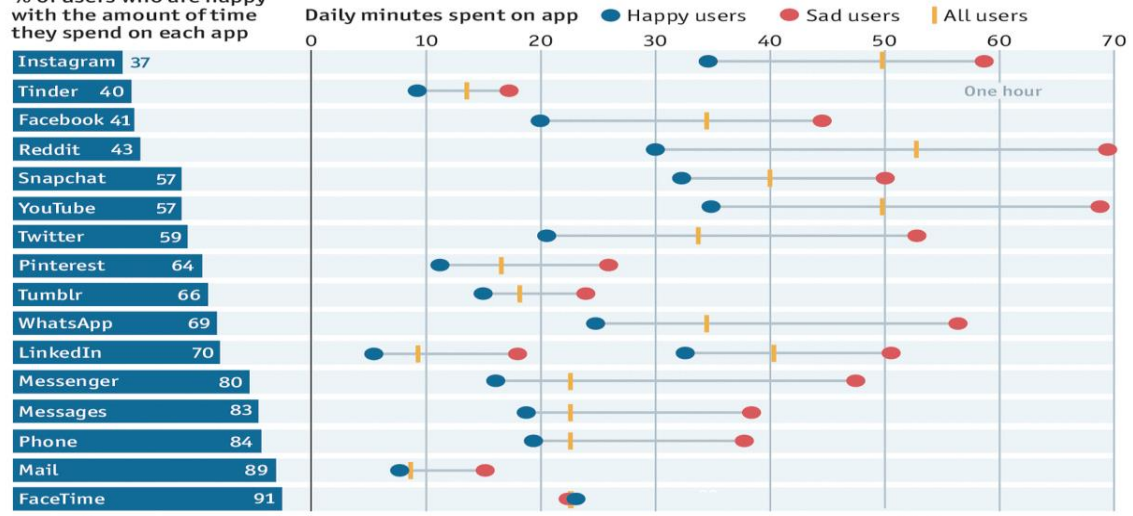

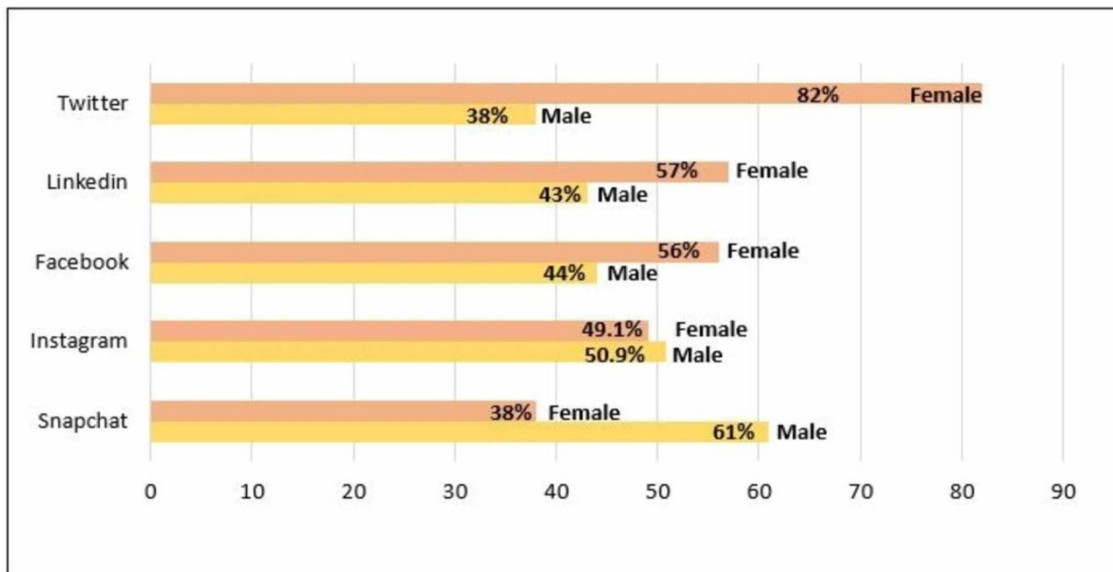


Figure: 4 Gender distributions of social media audiences worldwide as of January 2020

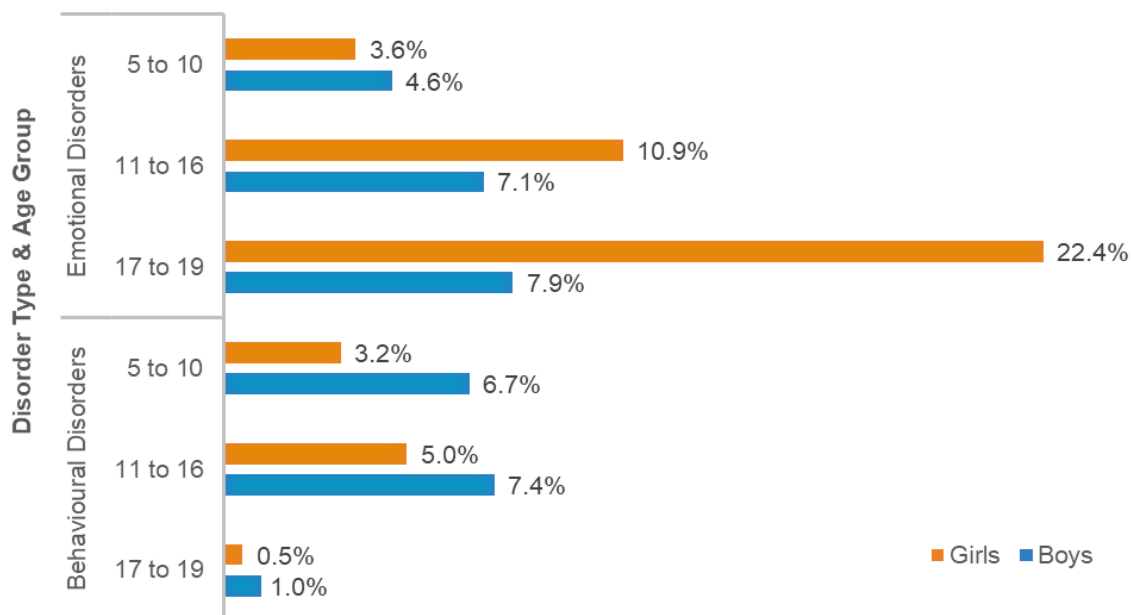
