However, the Muslim community in India neither stands as the only 'divorce declaring community nor shows the character of declaring highest number of divorces' in the country. Actually, there are many other communities, even in the religion of Hinduism, which practices the act of divorce and in some cases their rate of divorce is higher than the rate of divorce among Muslims.

Under the various Muslim divorce customs and acts, divorce among the Muslims is an option available to either of the spouses. The process of divorce is usually lengthy and hazardous, often starts with misunderstanding and issues related to child care, dowry etc in which both the parties have to suffer mental and at times physical assaults, this ultimately ends with the separation through the process of divorce. However, traditionally it has been seen that the practice of divorce among Muslim grants more opportunities to men than to women. Woman of course can seek divorce in cases where the husband deserts her, fails to maintain her, abjures her or if he is impotent. Various rules and procedures exists which deals with the obligation of marriage partners in general and the husband in particular in case divorce may occur.

Over the years, it has been found that among Muslim the word 'triple talaq' (se talaq) and its meaning has been misunderstood resulting its misuse especially among the middle class Muslim communities. It was essentially in this context, that the All India Muslim Personal Law Board had to frame a revised Nikah Nama, which among other things put a restrictive implication on the prevailing practice of tripletalaqamong Indian Muslims. It is important to note here that the divorce problem among Muslims in India is not only a religious problem but a social problem too. It is in this context that lower class and illiterate Muslims in general have higher incidences of talaqthan the upper-middle class and educated ones. Thus the practice of divorce among Muslims establishes socio-economic co-relation between this practice and many other factors.

Divorces in the Kashmiri Society

Traditionally speaking, marriage in Kashmir is governed by rule of kinship rather than courtship and is considered as a matter of inter-families and not inter-personal concerns, though Kins play a vital role during the mate selection. Exogamy is the dominant feature of this society but certain castes maintain the endogamy. However, the forces of modernization, westernization, modern education, and economic empowerment of women have changed the institution of marriage in over the past few decades. In fact, these developments have also been responsible for the increasing rate of divorce in the state. According to various sociologists and feminists groups operating in Kashmir including 'Women Commission, there has been an alarming increase in the number divorce cases in the state. According to the officials of the 'Matrimonial Court' of Jammu and Kashmir State, there has been 3540

percent increase in the divorce petitions filed in the court. Most of these petitions have been filed by the Kashmiri Pandit community living in Jammu for the past twenty years. According to the records available in the court, in the year 1995, 250 divorce petitions were filed in the state court, of which 30 applications came from Kashmiri Pandits. In 2001, the number increased to 976 petitions of which Pandits accounted for 300. In 2002, out of the 600 divorce petitions filed in the state, 200 were from Pandits mostly in the age group 25 to 40 years. The remaining applications for divorce came from the Dogra, Punjabi and Sikh communities. Further, according the officials in the court there has been an "unprecedented increase" in the number of petitions filed by women.

The State Women's Commission (SWC) maintained that over the past several years, the number of post-marital issues has seen an alarming surge particularly from the Kashmir valley. Of the 1820 cases registered with the commission since last few years, 1333 were from Kashmir and just 487 from Jammu region. The number of cases filed in the Srinagar branch on daily bases is around 20. This huge influx of cases has put the commission on toes. There is no specific reason for this tremendous increase in marital disputes but mostly the nature of the cases is issues related to dowry, lack of understanding between the couple, intolerance employment etc. Similarly the large numbers of cases are filed by lower income groups. Most of the time misunderstanding over small issues proves fatal and leads to divorce quite often despite our persuasion to negotiate the conflict peacefully. And contrary to the earlier trend the cases of coercion and torture has been decreasing. Ms. Shameema Firdous

Reason to blamed for the unsuccessful marriage:

Women are becoming independent: One of the main reasons why divorce rates are getting increased is because Indian women have grown a lot in the past few years financially, socially, and economically. There is no great dependency on the other person for these things. Earlier they used to remain in a relationship even if it was an abusive one, such as a dependency. Today, women are educated and smart enough to take care of them self in anyone's favor.
